It must be filed with the Environmental Review Appeals Commission within thirty (30) days after notice of the director's action. A copy of the appeal must be served on the director of the Ohio Environmental Protection Agency and the Environmental Enforcement Section of the Office of the Attorney General within three (3) days of filing with the board. An appeal must be filed with the Environmental Review Appeals Commission at 236 East Town Street, Room 300, Columbus, OH 43266-0557.

You should note that a general condition of your permit states that issuance of the permit does not relieve you of the duty of complying with all applicable federal, state, and local laws, ordinances, and regulations.


